
## **Updates to reflect Infrastructure Agreements**

### Introduction

Under delegation from the Minister for Economic Development Queensland, Council is proposing an amendment to the Maroochydore City Centre Priority Development Area (PDA) Development Scheme, referred to as the *Proposed Maroochydore City Centre Priority Development Area Development Scheme Amendment (no.2) 2018.* 

This information sheet provides details on proposed changes to the development scheme resulting from the finalisation of infrastructure agreements for the Maroochydore City Centre.



# Why update the Development Scheme to ensure consistency with infrastructure agreements?

Infrastructure agreements are now in effect for the Council owned land within the PDA. The Maroochydore City Centre Infrastructure Agreement 2017 and the Maroochydore City Centre Water Infrastructure Agreement 2017 came into effect in May 2017.

The infrastructure agreements were the subject of extensive negotiations with the state government and Unitywater and specify the infrastructure networks to be delivered for the City Centre including:

- water and sewerage infrastructure
- · parks and open spaces
- · roads and intersection upgrades
- · pedestrian and bicycle pathways
- smart city infrastructure
- public transport infrastructure
- community facilities infrastructure.


The infrastructure network maps in the development scheme have been updated to be consistent with the infrastructure network maps in the infrastructure agreements.

# What amendments are being proposed?


A number of maps in the development scheme have been updated to reflect the agreed road transport, active transport networks, and open space network in the Infrastructure Agreements.

As a result of the infrastructure agreement requiring the Transit Plaza land for transit infrastructure, a redistribution of urban open space has occurred. The base maps have been updated to reflect this requirement.


Existing Map 3: Structural Elements Plan



Proposed amended Map 3 - Structural Elements Plan







### Proposed amended Map 7 - Road Hierarchy Plan




