PROPOSED AMENDMENT TO THE MAROOCHYDORE CITY CENTRE PRIORITY DEVELOPMENT AREA (PDA) DEVELOPMENT SCHEME

Notice is given under sections 59 and 67 of the Economic Development Act 2012 that the Sunshine Coast Regional Council, under delegation from the Minister for Economic Development Queensland, is proposing an amendment to the Maroochydore City Centre Priority Development Area (PDA) Development Scheme.

The purpose and general effect of the proposed Maroochydore City Centre PDA Development Scheme amendment (no.3) is to:

- (a) give effect to a revised master plan layout and land use plan. The three key elements of the revised Master Plan that have informed the proposed amendment to the Maroochydore City Centre PDA Development Scheme involve:
 - · the consolidation of the waterway elements
 - · the consolidation of the parkland to the centre of the PDA
 - better leveraging the transit-oriented development opportunities in the PDA by redistributing some of the uses currently allocated to the existing Precinct 2 to the transit centre and to the parkland at the northern end of the consolidated waterway area
- (b) address other operational matters in relation to the above amendments and to improve the clarity and efficiency of the development scheme.

The proposed Maroochydore City Centre PDA Development Scheme amendment (no.3) is subject to public consultation from Monday 11 September 2023 to Monday 23 October 2023 (inclusive).

During the consultation period, a copy of the proposed Maroochydore City Centre PDA Development scheme amendment (no. 3) and explanatory material can be viewed and/or purchased at Council's Development Information Counter on the ground floor of City Hall, 54 First Avenue, Maroochydore.
